## Gordon Signy Fellowship Report

Institution: Brigham Women's Hospital, Boston, MA, USA.

Period: June to July 2017.

My training in the Dermatology Department/ Mihm Cutaneous Pathology Consultative Service at the Brigham and Women's started in June of 2017 and was focused on difficult diagnostic dermatopathology lesions, especially melanocytic lesions. My supervisors in this period were Drs. Martin Mihm and Adriano Piris, both experts in dermatopathology and extraordinary people. I also had help from a research fellow, Labib R.
