WASPALM IS INITIATING A WORLDWIDE TRAINING PROCESS STARTING IN LATIN AMERICA TO ENABLE THE SOCIETIES OF PATHOLOGY AND LABORATORY MEDICINE TO CO-ORDINATE AND EXECUTE ACCREDITATION ON MEDICAL LABORATORIES IN EACH OWN COUNTRY.

Although some big and medium laboratories have been, individually, accredited by other bodies, there isn't, in some countries, a commitment of these National Societies of our specialty. Concerning the importance of the quality management, guaranteeing trustworthiness of laboratorial exams the WASPaLM Bureau has approved one Workshop of Accreditation in Latin America under responsibility of Royal College of Pathologists and Brazilian Society of Clinical Pathology/Laboratory Medicine. The Uruguayan Society is already preparing the workshop enthusiastically. Dr. Mário Flávio Alcantara, Director-at-Large from Latin America and Dr. Wilson Scholnik from Secretariat of Education in Countries in Need are organizing it. The expectation is to have

around 150 Clinical Pathologists attendees and Governmental Authorities. We believe that Accreditation is a mandatory action of WASPaLM worldwide.

# **SOCIETY SPOTLIGHT**: The National Pathology Group of South Africa (Dr. Tjaart Erasmus)

First some background about South Africa. The country has a population of 43million and at 1.2 million square kilometres is approximately twice the size of Texas. The average life expectancy has declined significantly and is currently 44 years. This is a reflection of the HIV epidemic in the country with approximately 5.3 million individuals living with HIV/AIDS. It is estimated that there are 370 000 deaths annually attributable to this disease. The social impact and that on the health services, is tremendous.

The government is doing the best it can with limited resources. Government expenditure for the year 2004 was US\$61 billion with 13% spent on health and 23% on education and 19% on welfare. Government financial policies are conservative and have gone a long way towards creating a stable financial environment in the country. Progress is slow but steady and there is increasing capital inflow into South Africa from off-shore investments. The current GDP is 245 billion US\$.

Income disparity in South Africa is still very large, even though significant shifts have occurred over the past 20 years with an increasing black middle-class. The GINI index for South Africa is 59, compared to that of the USA at 41 and the United Kingdom at 36.

Healthcare in South Africa consists of state care for indigent or otherwise financially restricted or uninsured individuals. These services cover approximately 33 million of the total population. Roughly seven billion beneficiaries benefit from private medical insurance.

The privately insured individuals spend approximately US\$7.5 billion on their medical care. Approximately the same amount is spent by the government on the population which is unable to afford private medical insurance.

Since the democratisation of South Africa in 1994 it has been government policy to extend medical services to under served areas and the focus has moved predominantly to primary health care. This has been extensively criticized in many areas as it has lead to a significant retraction of academic and tertiary institutions. In order to extend medical services, new graduates are compelled to spend a period of one year at a public hospital, often in rural areas, to alleviate the shortage of medical practitioners.

# **Countries in Need** Dr. Robbie Bacchus, United Kingdom



The third WASPaLM educational enterprise was conducted in collaboration with the Royal College of Pathologists and the Indian College of Pathologists and the British Council in New Delhi between  $17^{th} - 21$ sr January 2005. The venue for this event was the India Prastha Apollo Hospitals which provided the supporting infrastructure for the event.

In the Indian subcontinent pathology signifies Anatomical Pathology/Histopathology, the other disciplines are categorised as clinical pathology. Accordingly a symposium was organised to cover some of the topics of interest importance and concern defined by discussions with Indian pathologists. The meeting was attended by 340 participants including six from Sri Lanka. The

participants came from all regions of India and several had travelled for 48 hours by train to participate in the event.

The symposium was inaugurated by the Minister of State for Science, Technology and Ocean Development. Other dignitaries included the Director General of the Indian Council of Medical Research , the chairman and dean of the Indian college of pathologists, director general of the Armed Forces Medical Services. The UK Faculty was led by the President of the Royal College of Pathologists Professor Sir James Underwood. The format for cellular pathology consisted of didactic talks and slide seminars and were sub-speciality based encompassing topics of breast, gastrointestinal tract and gynaecological pathology and digital imaging to enhance the importance of pathology in the clinical decision process several clinico –pathological symposia were held with the visiting faculty and local clinicians. These interactive sessions generated very animated and sometimes heated, though always friendly debate. Topics covered in the other disciplines include the immunological reactions to blood transfusion and the establishment of a cord blood bank quality assurance, quality standards and professional development, laboratory accreditation, the universal problem of MSRA, molecular diagnostic methods in microbiology, evidence based laboratory treatment options for myelomas, controlling infections and transplantation, developments in laboratory automation.

A reception was hosted by the British High Commissioner Sir Michael and Lady Arthur for the visiting faculty and Indian participants and an end of symposium dinner was hosted by the British Council.

To practice as a pathologist in South Africa, registration is required with the Health Professions Council of South Africa. There are currently 605 pathologists registered with this council. It is estimated that no more than 400 are currently in South Africa to serve the whole population.

Approximately half of the pathologists are in private pathology practice and half are employed by the state. The private pathology laboratories employ approximately 8000 people and most of the laboratories are accredited to the South African National Accreditation System (SANAS) which conforms to ISO/IEC17025 standard.

The National Pathology Group has approximately 200 members and its membership is predominantly drawn from the private pathology sector, but also has representation from the National Health Laboratory Service.

The objectives of the National Pathology Group are: to promote the practice and the professional interests of all pathologists in South Africa; to promote the use of pathology as a diagnostic tool for both the medical profession and the lay public; to establish professional relationships amongst pathologists with all role players; to promote the establishment and maintenance of acceptable standards in respect of pathology education and practice in South Africa; and to assist the promotion of the health of the population.

The National Pathology Group: acts as an organisational structure for private pathologists ,participates in professional forums, compiles and publishes protocols for billing, standardises laboratory request forms and promotes responsible and professional use of pathology.

We have many challenges within our country and appreciate the hand of friendship and collegiality that is extended by WASPaLM and its members.



# 23rd WORLD CONGRESS OF PATHOLOGY—ISTANBUL, TURKEY

The 23rd World Congress of Pathology was held in Istanbul, Turkey from 26 to 30 May 2005. Three constituent societies in Turkey cooperated to create an exciting technical and scientific program. The Keynote Lecture, entitled *Reticulum cells and reticulum cell tumours*, was given by Dr. Juan Rosai on the 26th of May.

Meetings of the Bureau, the House of Representatives and the World Pathology Foundation (WPF) made up the "business" part of the meeting. The Gala Dinner and Auction raised over US\$2,200 to support the WPF and the Gordon Signy Fellowships it offers to pathologists from countries in need seeking advanced training in other nations. #### New Work Item Proposals:

Genetic Testing-Specific requirements for quality and competence(N-149) submitted by the Japanese delegation will be postponed until the documents currently in preparation by the Organization for Economic Cooperation and Development(OECD) are available.

Laboratory Medicine-Estimation and reporting of measurement uncertainty of routine values(N141) was approved as an activity of WG-2 with WG-1 advising. The project will be a joint activity with CEN/TC 140 and the first meeting will be scheduled for Jan 2006.

NWIP on" Health Informatics-Structure for nomenclature, classification, and coding properties in clinical sciences" was withdrawn by the Swedish delegation to be resubmitted to ISO/TC 215.

# **Reports of Working Groups:**

WG-1: Quality management in the clinical laboratory

change the name of the working group to "Ouality and competence in the medical laboratory"

- ISO 15189 will be minimally revised to conform with ISO 17025. These revisions are mainly with terminology to conform the two documents. ISO 15189 draft amendment 1 will be circulated for vote. ISO 15189 will have a major revision to be completed by 2008 along with the revision of ISO 17025. This revision is stated to address the needs of the medical laboratory and related accreditation bodies.
- WG-1 will contact ILAC to develop a guidance document on the use of ISO 15189 by accreditation bodies to be jointly developed with WG-1. This document would be similar to ISO 22869 the guidance document on laboratory implementation of ISO 15189.

## WG-2:Reference Systems

Did not meet but the NWIP concerning measurement uncertainty was approved.

#### WG-3: In vitro diagnostic products

- ISO 14971 annex on risk management for IVDs shall be circulated for DIS vote. If vote affirmative the responsibility for the document will transfer to ISO/TC 210.
- ISO 18113 will be divided into 5 parts . These documents address information supplied by the manufacturer for "labeling" of in vitro diagnostic medical devices.
- Comments were addressed on ISO 17593, Requirements for in vitro monitoring systems for self-testing of oral anticoagulant therapy and this document will be submitted for final draft international standard.

#### WG-4: Antimicrobial Susceptibility Testing

Comments will be addressed concerning ISO 20776-1(Reference methods for in vitro testing of the susceptibility of antimicrobial agents against bacteria involved in infectious diseases) during the DIS voting.

ISO 20776-2(Evaluation of performance of antimicrobial susceptibility devices) will be drafted with CEN/TC 140 and submitted for DIS vote in the fall of 2005.

The next meeting of ISO/TC212 will be held in Berlin 31 May to 2 June 2006.

Additional actions of the House included a favorable recommendation for Constituent Societies in Italy to host the 2011 World Congress and encouragement for WASPaLM Constituent Societies to financially support WASPaLM membership for societies wanting to join but without the financial resources to do so. In addition, the House of Representatives received the list of **Bureau actions** at Istanbul.

Action Item #1: The Bureau received the proposal from Prof. Simone and agreed to present it to the House of Representatives and seek their advice and recommendation prior to taking formal action.

Action Item #2: The Bureau approved without change the document entitled "Final Draft of the Bylaws of the World Association of Societies of Pathology and Laboratory Medicine" for presentation to the House of Representatives.

Action Item #3: The Bureau authorized its members to solicit, based upon requirements drafted by Sidley and Austin, proposals for liability and directors insurance in their several countries.

Action Item #4: The Bureau authorized an expenditure of up to £2,000 for the Secretariat for Countries in Need to conduct a workshop in Bangalore, India in February 2006.

Action Item #5: The Bureau agreed to accept the ControlLab proposal effective immediately and to consider, at the next Bureau meeting, whether any additional support from services providers other than ControlLab is required.

Action Item #6: The Bureau reconsidered its action regarding the allocation of £2,000 for the Secretariat for Countries in Need.

Action Item #7: The Bureau voted to reaffirm its previous decision to allocate £2,000 of contingency funds for a workshop in Bangalore in February 2006.

Action Item #8: The Bureau approved the allocation of up to US\$2,000 to support the faculty conducting he accreditation program of ALAPAC being held in Montevideo in June 2005.

Action Item #9: The Bureau approved continuing the educational program for countries in need *in principle* for another three years and granted funding of £7,000 for the first year (2007).

Action Item #10: Dr. Mori will call Dr. Lee to discuss the status of the Taiwan Society of Clinical Pathology and will inform the Bureau of the outcome of his discussion by email.

Action Item #11: The Bureau combined the Informatics Secretariat and the Web Editorial Committee and directed that official correspondence between WASPaLM and WHO be conducted with Dr. Utz Merten.
